B. Matters from the Councilors

a. Councilor Audrey Jaramillo

Councilor Jaramillo spoke about the many contributions that she has provided to the Town. She also stated that she feels that Mayor Bassett doesn't communicate and isn't open to feedback. She stated that she feels that her calling is to be the voice for the people.

b. Councilor Sherry Abraham

Councilor Abraham stated that she is also a voice for the people. She stated that the Wastewater Treatment Plant violations need to be addressed, she stated that there has been no information regarding the Church Street Paving Project and is concerned about the EPCOR takeover. She stated that there is not enough discussion on items.

d. Councilor Linda Holle

Councilor Holle spoke about the college courses being offered by Central New Mexico Community College. She also announced that Church Street Market won two awards for Best Market Idea and Best Budget Shopping. She also thanked staff for the Christmas Tree Lighting.

Councilor Abrams made a motion to approve on Resolution 2019-25 - A Resolution to move Town of Edgewood operations to a 100% renewable energy goal. Councilor Holle seconded the motion.

Councilor Abrams stated that the State of New Mexico will eventually be all solar, they are aiming for 80% by 2045. He would also like the Town to be all solar and would like to see the bids. He believes the Town should be moving in this direction. Councilor Holle stated that she is concerned of the burden this may place on staff. Mr. Torres suggested that it be include this on the ICIP (Infrastructure Capital Improvement Plan) and it will be up to the discretion of the Governing Body. Councilor Abraham asked for a cost analysis for the project and stated that the Town should focus on the current projects that are not yet completed instead of bringing in new ones. Councilor Jaramillo stated that she was concerned about debt and also requested as cost analysis. She requested that Central New Mexico Electric Coop come to a meeting to speak about this. She stated that the language in the Resolution is painting it to go one way, which is not true. Mayor Bassett stated that we would be working on one facility at a time, not all at once to keep costs feasible. Councilor Abraham suggested the Town work towards a 75% goal instead. Mr. Torres stated that there is no timeframe that the 100% goal has to be met. Councilor Abrams suggested we look into this.
