CALL TO ORDER.

B. Matters from the Councilors

a. Councilor Audrey Jaramillo

Councilor Jaramillo stated that opening meetings with a moment of silence and a prayer is allowable per Randy Van Vleck, the attorney for the New Mexico Municipal League, and suggested adding prayer to begin each meeting. Councilor Jaramillo also thanked Deputy Clerk Carla Salazar and Librarian Andrea Corvin for meeting with her to speak about Youth Programing for the community, she stated that the meeting went well and they are planning on

scheduling programing. She stated that Governor Grisham has vetoed Capital Project money, but there is other funding available for these programs.

b. Councilor Sherry Abraham

Councilor Abraham requested to add a discussion on the next meeting's agenda to discuss the Town's Personnel Policy as she believes there are updates and changes that need to be made. Councilor Abraham also requested that an attorney be present at Council Meetings once a month, she stated that she has requested this multiple times and asked where Council stands on this. Clerk/Treasurer Juan Torres stated that he polled Council and majority of the Council showed no interest.

c. Councilor John Abrams

Councilor Abrams stated that with former Mayor Howard Calkins passing, he would like to request a Resolution to dedicate a day as Howard Calkins day. Councilor Abrams also stated that we need to be careful about including an opening prayer because not everyone is of the same belief. He also suggested that with the current coronavirus pandemic, Council should consider moving the meetings to once a month to help not spread the virus.

d. Councilor Linda Holle

Councilor Holle spoke about the Community Cleanup Day that is taking place on March 21st at the Edgewood Soccer Field Park from 9am to 5pm. She also spoke about the Community Gardening Series which is scheduled to begin on March 7th.

C. Matters from the Clerk/Treasurer

Clerk/Treasurer Juan Torres spoke about the IRS Audit that is currently taking place. He stated that the audit was brought about by an error on the IRS side with transposition of payroll numbers being incorrect. He stated that everything else was good and we are doing everything as we should be. He also stated that when the Town first incorporated, an agreement regarding Social Security deductions was never completed, therefore we are current taking the necessary steps to correct the issue. He also stated that the Town is still waiting to hear from Santa Fe County about the dispatch services. Councilor Jaramillo asked if the Town is doing anything to promote Census Day and she would like to volunteer her time to help. Mr. Torres stated that yes, we are taking measures to promote and support Census and Planning and Zoning Administrator Tawnya Mortensen has been attending meetings and is heading the project.

D. Matters from the Mayor

Mayor Bassett spoke about the coronavirus and the advisory given the Governor Grisham and the New Mexico Department of Health. He stated that the Governor has vetoed much of the Capital Outlay money, but the Town is still going to receive Capital Outlay funding for improvements to the Wastewater Treatment Plant.

Mayor Bassett stated that the Road Department Supervisor, Norton Henninger recommended that the funding be used to improve the surface of Frost Road.

Councilor Abraham asked about the estimated cost of the project. Mr. Torres stated that the engineer's estimate is around \$130,000. Councilor Abraham asked if this is the last item on the NOV. Mr. Torres stated yes.

PROCLAMATION

IN HONOR OF THE MILITARY ORDER OF THE PURPLE HEART

WHEREAS, The Purple Heart is the oldest military decoration still in present use and was initially created by George Washington in 1782, as the "Badge of Military Merit"; and

WHEREAS, The Purple Heart was the first American Service Award made available to the common soldier, and is awarded to any member of the United States Armed Services wounded or killed in combat with a declared enemy of the United States; and

WHEREAS, The mission of The Military Order of the Purple Heart, chartered by an act of Congress, is to foster an environment of goodwill among the combat-wounded veteran members and their families; to promote patriotism; to support related legislative initiatives; and, most importantly, to make sure we never forget the sacrifices made by those so decorated; and

WHEREAS, Edgewood has a highly decorated Veteran population including Purple Heart Recipients; and

WHEREAS, There have been former Edgewood residents who made the ultimate sacrifice in giving their lives in the cause of freedom, and there are combat-wounded veterans who currently reside within the Town of Edgewood, and as Purple Heart awardees who contribute to their community in countless ways; and

WHEREAS, the Town of Edgewood falls within the purview of Chapter 1966 of the New Mexico Military Order of the Purple Heart and wishes to pledge its strong support, honor and gratitude for this noble organization and for those who put their lives at risk in service of their Country and their fellow citizens.

NOW, THEREFORE, I, John Bassett, by virtue of the authority vested in me as Mayor of the Town of Edgewood, do herby proclaim the Town of Edgewood, Santa Fe County, New Mexico a
